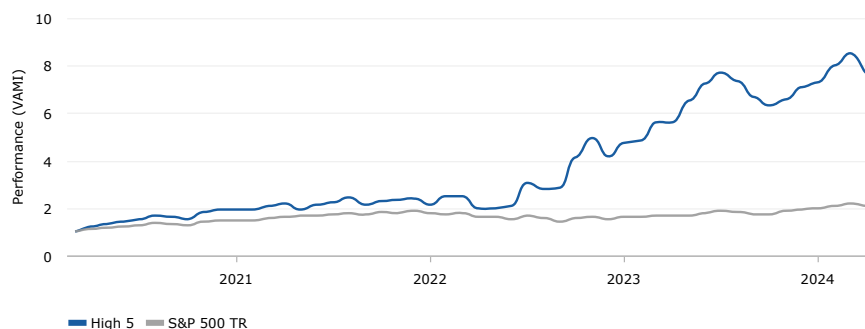
### STRATEGY DESCRIPTION

Inverse equity funds for the same index is used to support short positions indicated by the composite. Positions are not rebalanced until a change in exposure is called for by composite trade calls. The strategy is volatile and high drawdowns along with high standard deviations are expected. The benchmark is the S&P 500. The High 5 Composite was created April 2020.

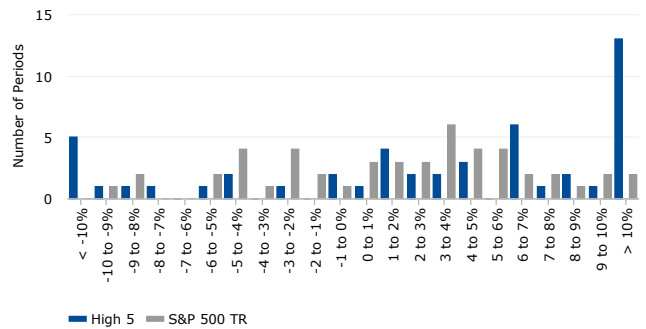

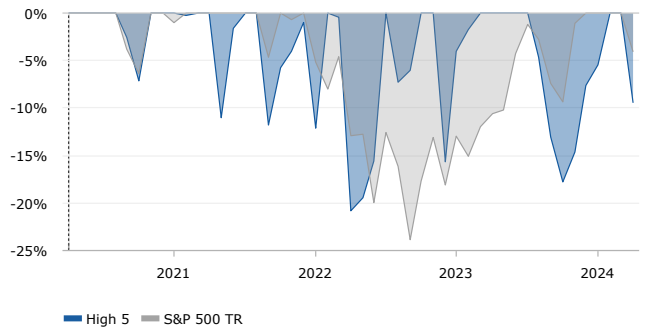
## DISTRIBUTION OF MONTHLY RETURNS



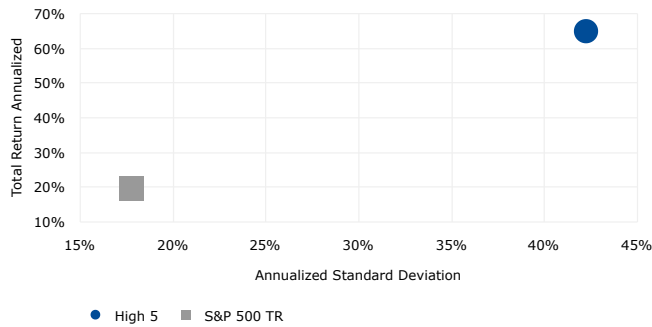

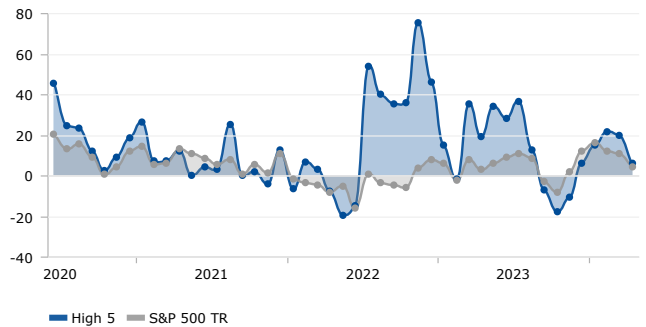

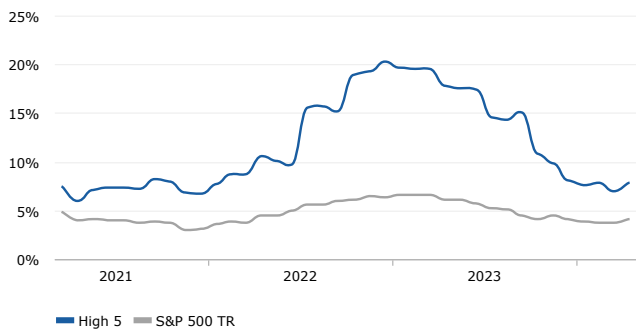
## RISK/RETURN COMPARISON



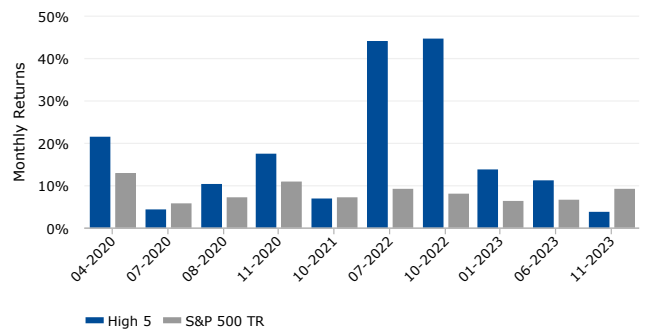

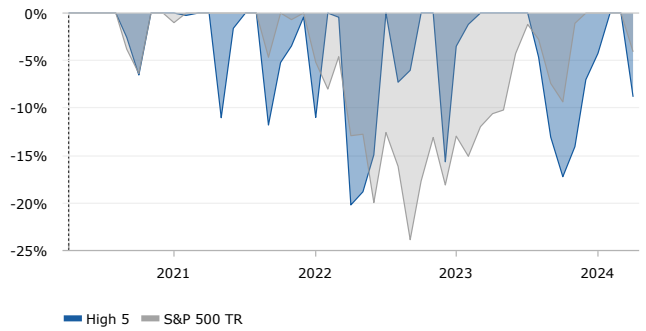
## DISTRIBUTION OF MONTHLY RETURNS



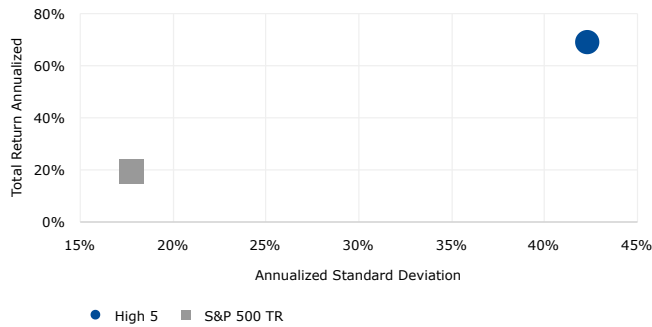

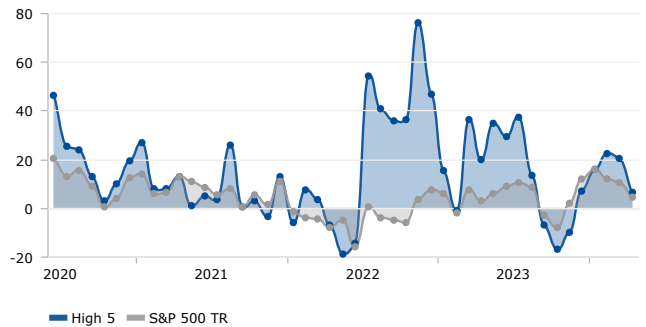

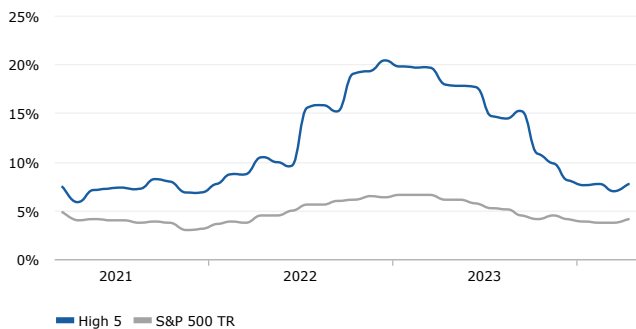
## RISK/RETURN COMPARISON



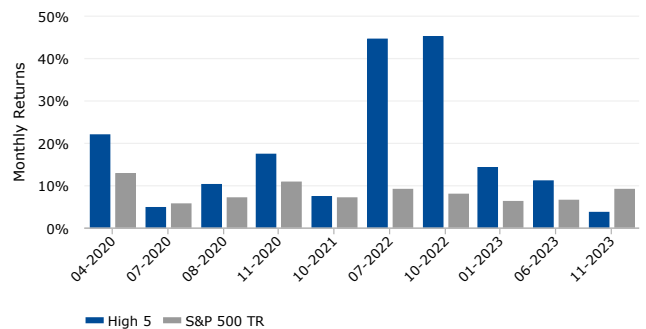
