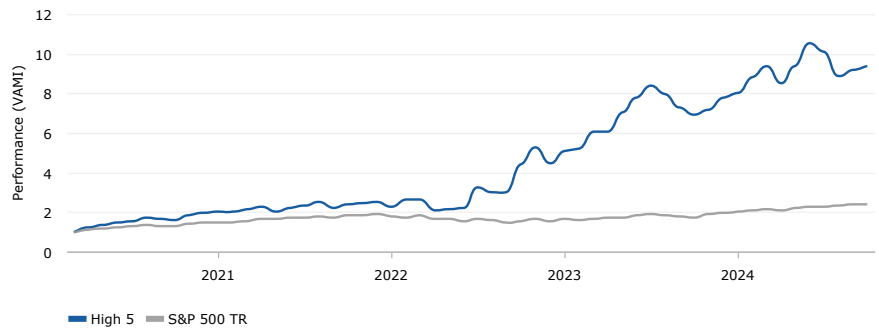

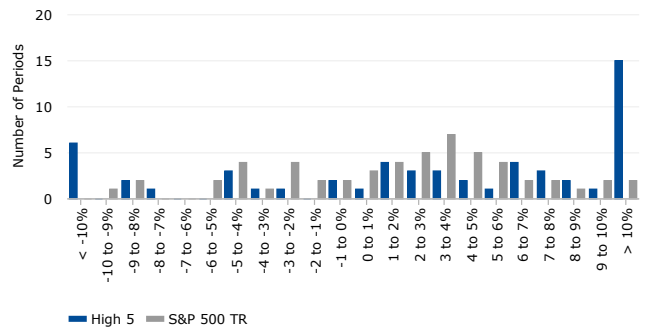

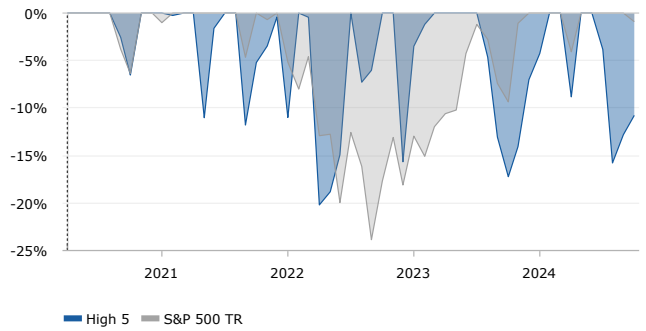
DISTRIBUTION OF MONTHLY RETURNS



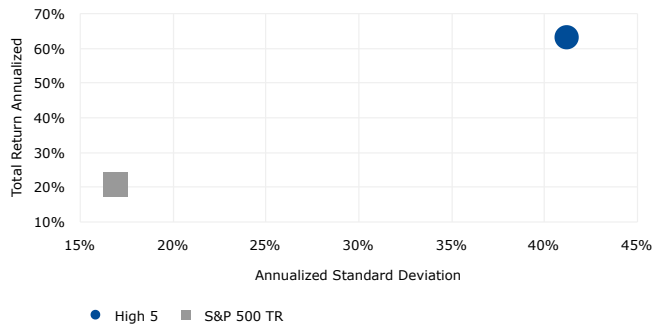

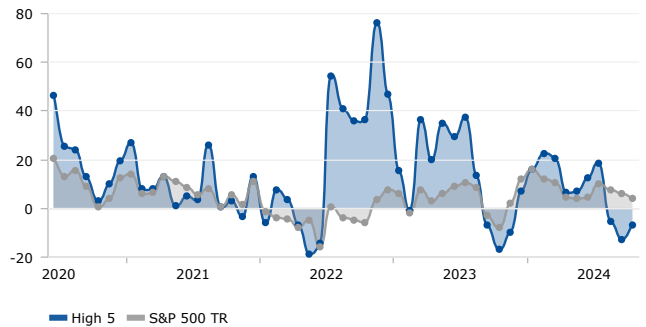

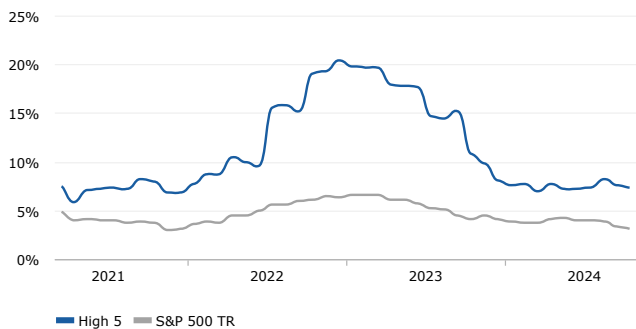
RISK/RETURN COMPARISON



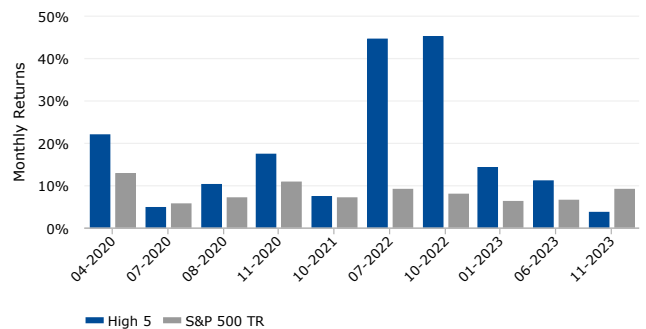
3 MONTHS ROLLING ROR

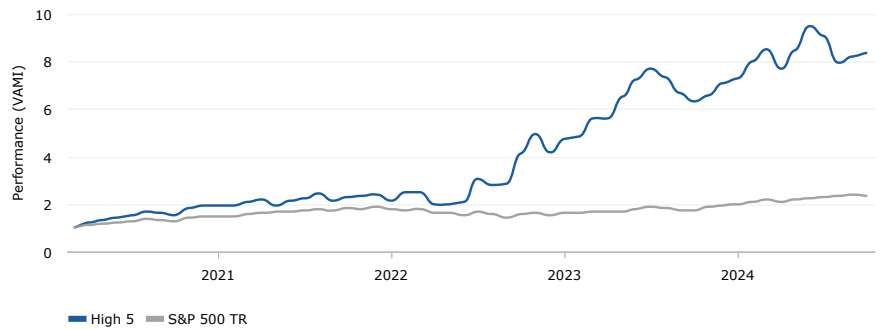

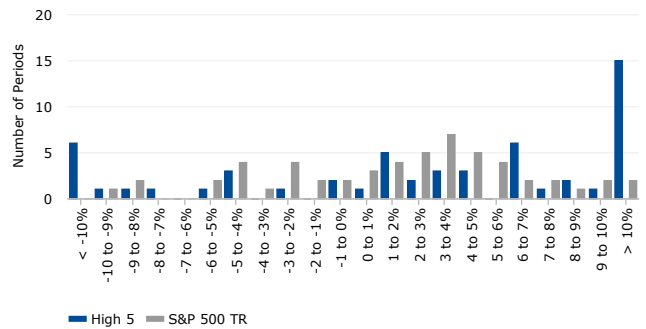

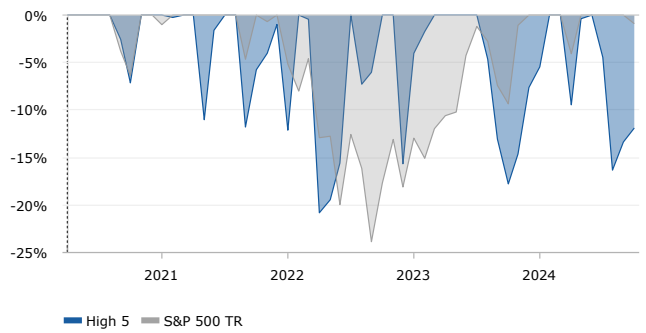
DISTRIBUTION OF MONTHLY RETURNS



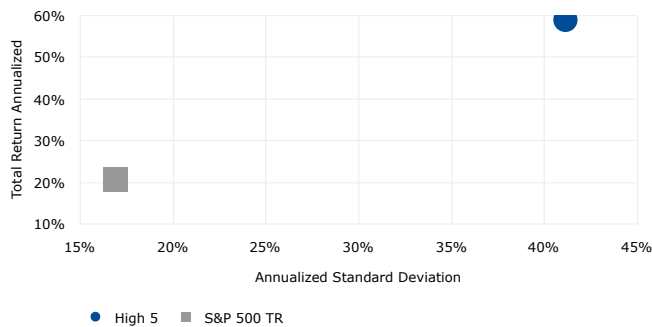

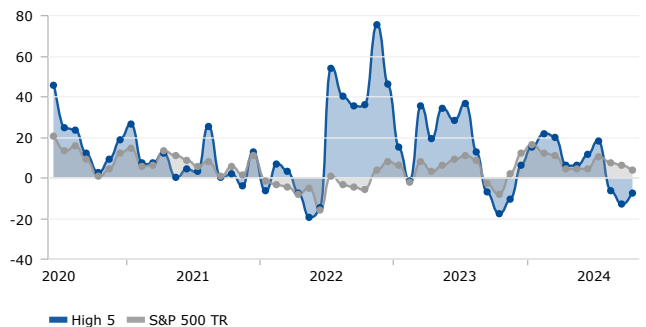

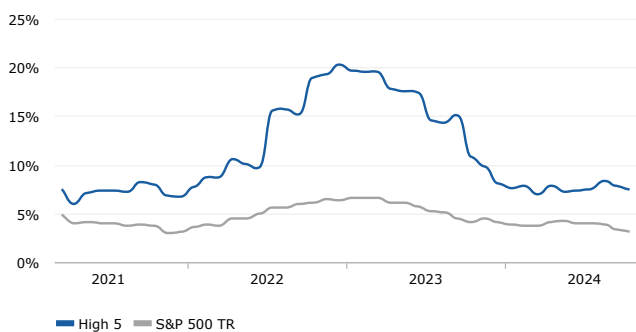
RISK/RETURN COMPARISON



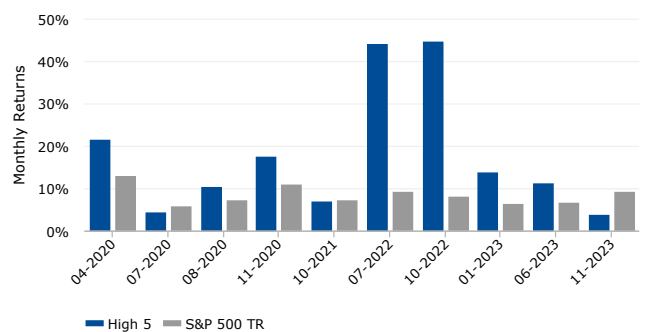
3 MONTHS ROLLING ROR
