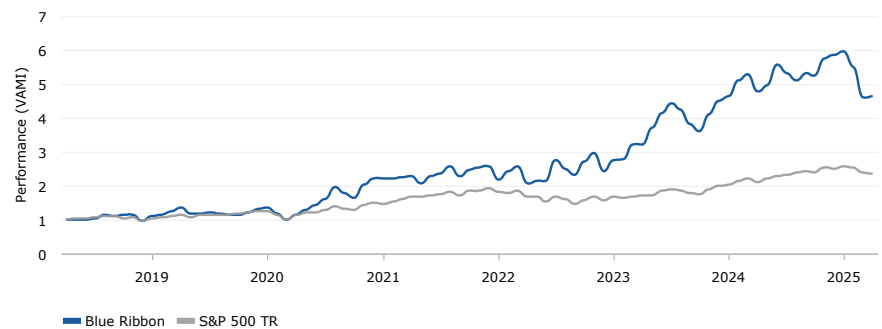

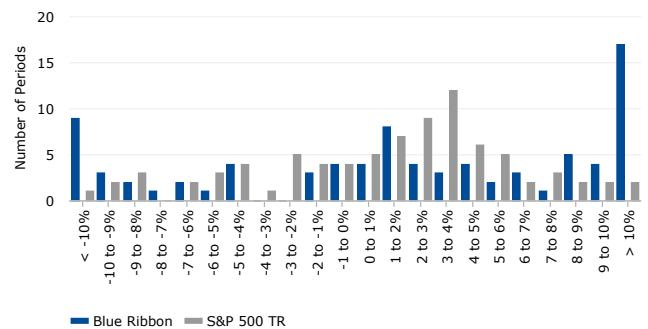

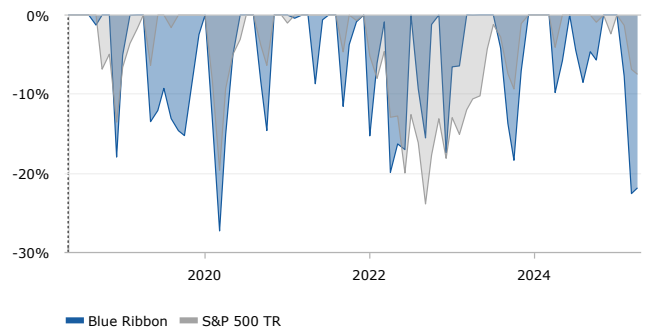
## DISTRIBUTION OF MONTHLY RETURNS



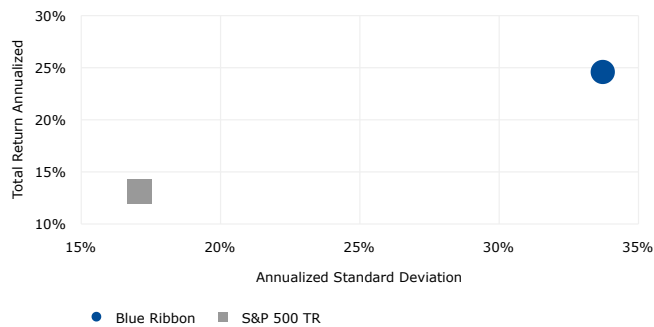

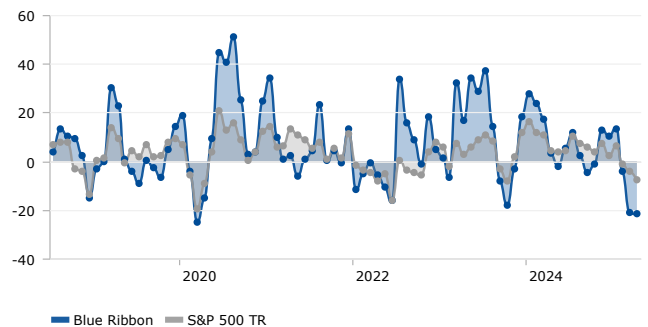

## RISK/RETURN COMPARISON



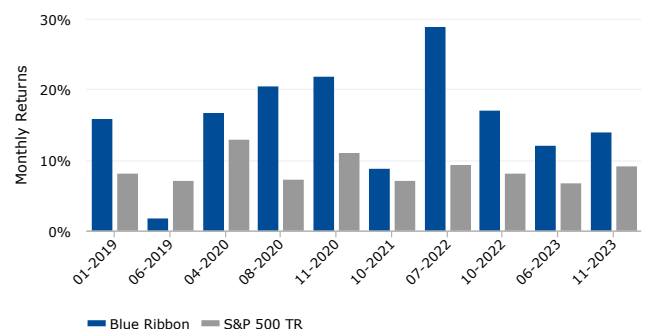
## 3 MONTHS ROLLING ROR

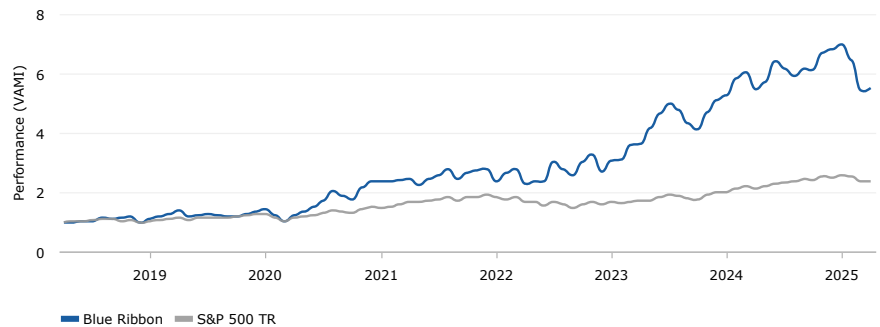

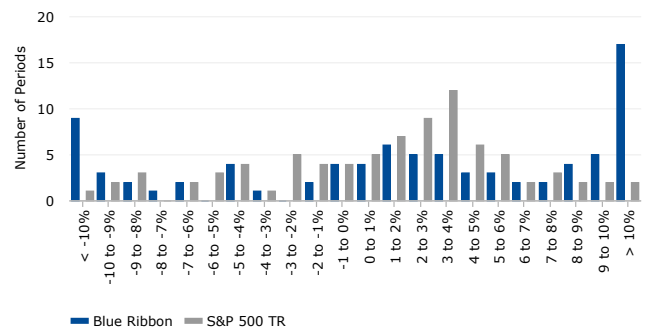

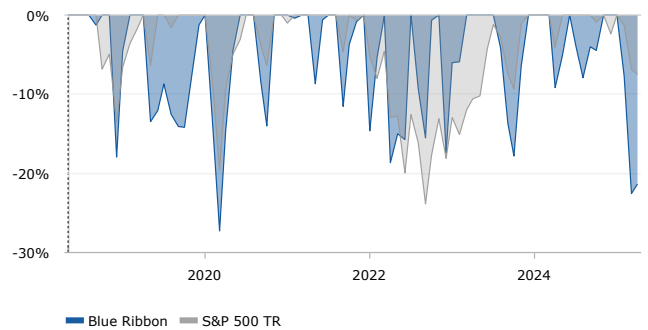
## DISTRIBUTION OF MONTHLY RETURNS



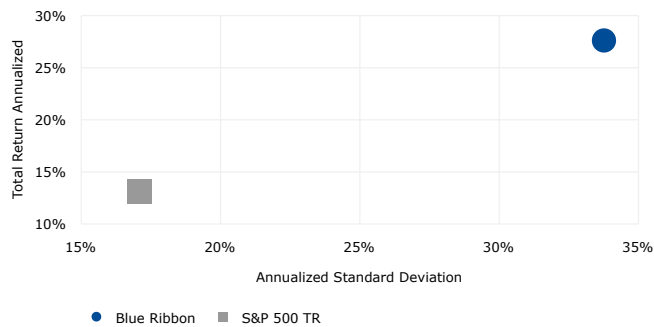

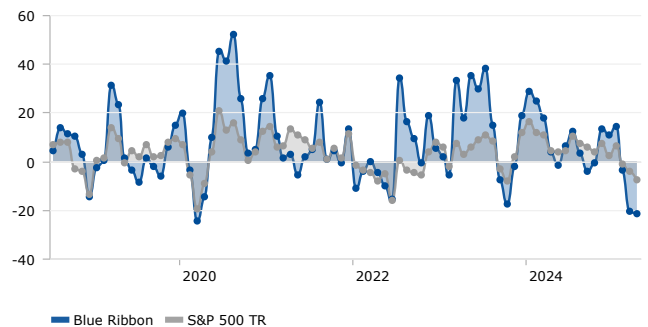

## RISK/RETURN COMPARISON



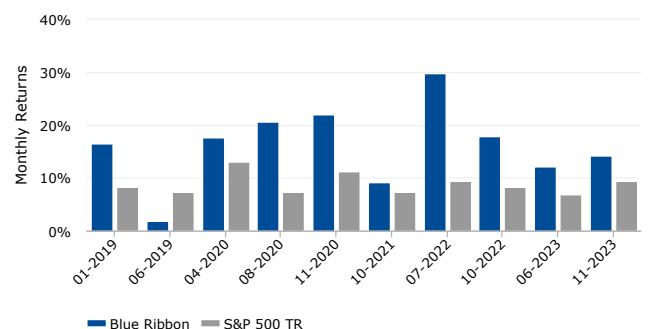
## 3 MONTHS ROLLING ROR
